This Order is made by Oldham Borough Council ("the Authority") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that the footpath described in paragraph 1 below is not needed for public use.

BY THIS ORDER:

1. The public right of way over the land situate at Hey Hill Farm, Low Crompton Road, Royton shown by a continuous bold black line on the map attached to this Order and described in the Schedule to this Order shall be extinguished after 28 days from the date of confirmation of this Order.

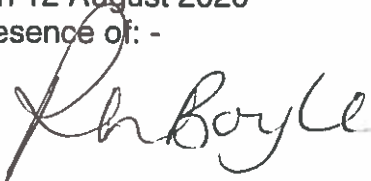
